Secretary's Report

2025 GCTTA AGM

Membership, Fixtures, Tournaments & Events

The Club continues to reach new heights, achieving a record membership of over 300 members for the first time in 2025. We have seen a high number of players participating in social/casual sessions, fixtures, and our Gold Coast Open Championships.

Many thanks to the fixture/tournament Committee for their ongoing efforts with the organisation of teams, schedule & events and all the volunteers on duty for their dedication and constant work in making social/casual days enjoyable for the Members & visitors and for introducing new players to the Club.

The centre also hosted several local, State, and National tournaments throughout the year, and we extend our thanks to all the staff and volunteers who were heavily involved in the successful delivery of these events.

Club Upgrades & Developments

 - 2025 Sport & Recreation Disaster Recovery Program: grant to assist with the clean-up efforts following Cyclone Alfred.
 - City of Gold Coast Active & Healthy Social Sport Program: equipment resources to support seniors' table tennis sessions.
 - QLD Government Sport & Recreation Play On vouchers for junior participation.
- Much appreciation and acknowledgment to the QLD Government, City of Gold Coast, Table Tennis Queensland, Table Tennis Australia and other key stakeholders for their support!
- Throughout the year, we completed some minor centre maintenance including improvements to the driveway/excavation, garden and lawns, court equipment, electrical works and painting of walls and walkways.
Major works included roof repairs with the installation of new ridge capping, as well as sewerage upgrades, including pump-out and septic tank improvements.
 - The Club has continued its partnership with Table Tennis World, our equipment supplier and sponsor of the East-Coast Veterans and Gold Coast Open. We also welcomed Robam QLD Kitchen Appliances as a new sponsor, contributing gifts and prizes for the winners at the Gold Coast Open Championships.
 - We would like to express our gratitude and many thanks to the members who worked and assisted with various Club activities, including Mick, Phil, Geoff, Ernie, Jakob, Naoya, John, Shameem, Tiffany, Van, Charlie, Greg, Andy, Petr, Kenny, and all other helpers. - The centre continues to host the Broadbeach Seniors TTC on Wednesday and Friday afternoons — thank you to John and Karen for running these senior/casual sessions and for welcoming players of all levels.
- Additionally, the centre hosted several schools for sport gala days and social events throughout the year, as well as the Gold Coast Sport Inter-School Competition during school terms.

Treasurer's Report

The Gold Coast Table Tennis Association has achieved another record financial year, marking its highest gross income and exceeding operating profits to the previous year. The Association remains in a strong financial position, with average weekly takings of approximately **\$5,020** and average weekly outlays of around **\$2,150**.

Income Overview

The Association's **weekly fixtures and social/casual sessions** continue to serve as its primary source of income, generating **\$121,150** for the year. Other significant income streams include:

- **Memberships:** \$26,300
- **Coaching:** \$27,000
- **Canteen Sales:** \$15,200
- **Equipment Sales:** \$19,900
- **Hall Hire, Events, Schools and Other Groups:** \$45,400

These figures represent a substantial increase across most income categories compared with the previous financial year.

Operating Expenditure and Utilities

Increased centre usage and rising energy rates over the past 18 months have reduced the Association's solar feed-in capacity, resulting in the loss of prior energy credits. The current electricity account averages a **debit of approximately \$1,500–\$2,000 per quarter**.

Despite these higher utility costs, the additional income generated from extended operating hours more than compensates for the increased expenditure. The Committee is presently investigating the installation of a **solar battery system** to help mitigate future electricity costs and enhance sustainability.

Fundraising and Donations

Through **sponsorships, raffles, social activities, and contributions to the Agnes Foundation**, the Association received total donations of **just over \$2,500**. We extend our sincere appreciation to all patrons and supporters for their generosity and encourage ongoing support of both the Club and the Agnes Foundation.

Interest Earnings

The Association's interest-bearing cheque account earned **\$927** in interest over the 12-month reporting period.

Maintenance, Upgrades and Development

Several maintenance projects and facility upgrades were undertaken during the financial year, including:

- Centre maintenance, driveway works, sewerage repairs, and fire services – **\$11,400**
- Roof repairs (installation of new ridge capping) – **\$5,340**
- Electrical repairs – **\$770**
- First Aid & CPR training – **\$892**
- Building and Business insurance renewal – **\$10,875**

Grants and Funding Support

The Association was successful in securing several grants throughout the year, including:

- **Queensland Government MIIFF (2023–2025) completion of amenities:** second payment of funding – **\$60,595** (*total project cost exceeding \$160,000*)
- **Queensland Government Sport & Recreation Disaster Recovery Program (2025):** Cyclone Alfred impact and clean-up efforts – **\$5,500**
- **City of Gold Coast Social Sport Program (2025–2026):** Equipment supplies – **\$880**
- **Queensland Government Play On Vouchers:** Junior player participation support – total value **\$9,600**

It should be remembered that our Association is a not-for-profit organisation and any income generated is used to improve the Club and centre services for the benefit of the Members.
